Large Families: May be eligible for a sibling discount. Active Parishioners: Parishioner of the Church who participates in the faith life of the parish by giving fully of their time, talent, and treasure and by regularly attending Sunday Mass and Holy Days of Obligation may be eligible for financial assistance. In addition, I agree that a \$100 late fee will be assessed for tuition payment after the due date and \$50.00 fee will be assessed for check(s) returned from the bank marked "INSUFFICIENT FUNDS", and two (2) returned checks will place the account on a cash basis only.

At the end of each quarter, parents with past due tuition/fees balance will be notified by the school finance office of the past due amount and the minimum payment required. If all financial obligations are not current, the school will:

- Not allow the student to take mid-term/final exams.
- Block the online grade view for both the student and parent.
- Not issue report cards, diplomas and/or transcripts.
- Disenroll the student from the school.

It is further agreed that enrollment, as specified within this enrollment contract, may be cancelled by the parents or guardians in writing, without penalty (except forfeit of non-refundable registration fee), **prior to August 5, 2021**. Official transcripts will only be issued if all financial obligations have been met.

The school shall have the right to legal action for collection of school fees and tuition. Parents will be responsible for all costs of collections, including court expenses and attorney fees. The undersigned agrees to release and hold harmless, the school, its agents, and employees from all claims, damages, or other liabilities for injuries to my child that are not the result of gross negligence by this school, its agents, or employees. The undersigned also agrees to indemnify the school for damages by my child.

Parents or Guardians must sign this enrollment contract in duplicate and return one copy to the school. This instrument shall be interpreted in accordance with the Laws of the State of Florida.

I acknowledge that I have read, understand and agree to the 2020-2021 tuition and fee schedules and payment obligations detailed in my tuition statement. In exchange for the admission of my child(ren) in Immaculata-La Salle High School, I hereby agree to pay, as scheduled, the net tuition due.
